Subject: Notice of Intent to Award a Contract under RFP ETC0051 Strategic Partner for Pension Administrative System

Dear Mr. Haws,

On September 21, 2023, the State of Wisconsin Employee Trust Funds Board (Board) granted authority to the secretary of the Wisconsin Department of Employee Trust Funds (ETF) to issue an intent to award a contract on behalf of the Board to Linea Solutions to consult as a Strategic Partner for a Pension Administration System for a five-year period beginning on January 1, 2024 through December 31, 2028, with an option to renew the contract for two additional two-year periods, subject to successful contract negotiations. The bid abstract for this solicitation is on the following page.

Due to the time sensitive nature of an executed contract, the Board approved that in the event of failed or prolonged negotiations with Linea Solutions, the secretary be allowed to commence contract negotiations on behalf of the Board with The Segal Company.

RFP ETC0051 Section 3.10 describes the Board's policy for vendor procurement appeals. The Board is not required to award contracts to the highest scoring proposer or the lowest cost proposer.
